ORDINANCE AMENDING CHAPTER 27 OFFENSES SECTION 27-2-20
DISCHARGE OF FIREARMS OR BOW AND ARROW, OF THE REVISED CODE OF
ORDINANCES OF THE CITY OF SULLIVAN, ILLINOIS

BE IT ORDAINED by the Council of the City of Sullivan, Illinois, that:

SECTION 1: CHAPTER 27 – OFFENSES, ARTICLE II – GENERALLY, SECTION 27-2-20 shall be amended to read as follows:

27-2-20 **DISCHARGE OF FIREARMS OR BOW AND ARROW.** It shall be unlawful to discharge any firearm, bow and arrow or air gun within the City limits or in such a manner that the bullet, arrow, missile or projectile therefrom enters the City limits without prior written permission from the Mayor. This section shall not be construed to prohibit any officer of the law from the discharge of a firearm in the performance of his/her duty or during training or qualification at a City owned gun range; nor to prevent any citizen from discharging a firearm when lawfully defending his person or property; nor to prevent the use of a bow and arrow by students upon school grounds while under the direct and immediate supervision of a teacher or other school supervisory personnel.

SECTION 2: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 3: This ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.

SECTION 4: This ordinance shall be known as Ordinance No. 18-18.






CERTIFICATE
